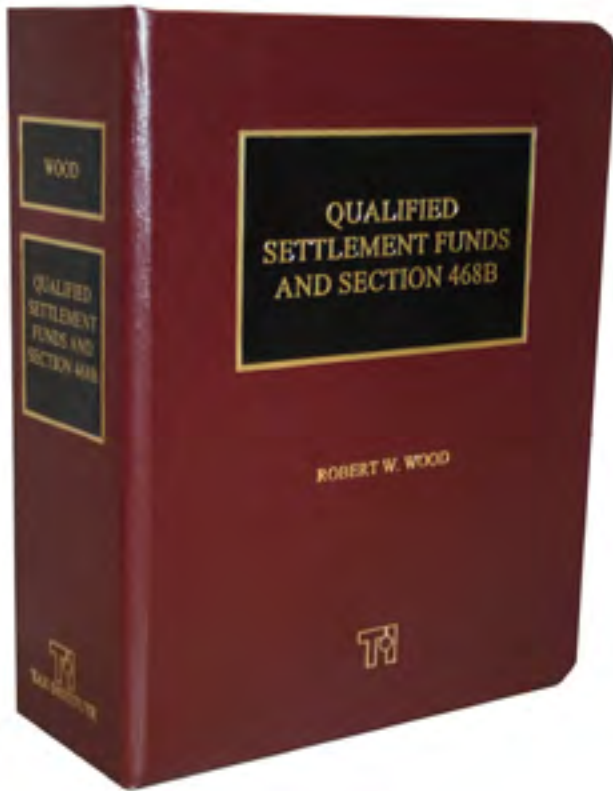


# Qualified Settlement Funds and Section 468B
